## Minutes (approved)

- 1. Call to order: Jan O'Connor called the meeting to order at 5:50 PM.
- 2. Approval of Minutes of the October 15, 2014 Board meeting: Mike Kelly moved and Terrance McKerrs seconded that the minutes from the October 15, 2014 meeting be approved. Motion approved.
- 3. Treasurer's Report: Since Jan Tillery had not received the bank statement, there was no Treasurer's Report. - 4. Status of information from Capital Federal (Jan Tillery): Jan O'Connor agreed to handle the presentation of the check in Feb, the meeting with Capitol Federal, and any negotiations with Cap Federal for sponsorship.
- 5. Report from February tournament committee: Dave Chipman, Jerry Sloan, and Mike Kelly met with the Lawrence Holiday Inn yesterday. The Unit Board has a commitment from the Holiday Inn for the 2015 and 2016 sectionals. The Holiday Inn is sending a contract for our signature, for the February, 2015 sectional. (NOTE: We will be able to put things on the walls during the tournament)
- 6. Report from tournament subcommittees: Jan O'Connor shared information from the subcommittees: Chris Lane purchased several items to recognize the Newcomers: Paula Schumacher is working with Grant Sutton to organize the Partnership Desk; Klee Zaricky is working on Hospitality; The tournament committee may need to add people from other clubs to help the Manhattan players on the Registration Desk; Jan O'Connor will work with Terrance McKerrs on Publicity and Promotion; and, Rich Bryan will donate bottles of wine for door prizes during the tournament.

Dave Chipman, Mike Kelly and Jerry Sloan discussed what could be done for the Newcomers during the February sectional tournament. One idea was to charge half-price [entrance fee] to anyone that had less than 5 master points.

Jan Tillery indicated that she will submit a request for Fast Results for the tournament.

7. Free play policy: Dave Chipman, Mike Kelly and Jerry Sloan recommend fewer 'free plays' for the February, 2015 sectional, as compared to last year's sectional (Dave has yet to determine how many free plays were provided last year). Jan Tillery gave Dave the financial reports of the 2012 and 2013 sectionals. Dave then gave them to Jan O'Connor who will also read them and then place the reports in the Unit's file cabinet.
